
AUTO LEVEL

LED LEVELING INDICATOR

The Auto Level is an LED based leveling indicator that can be used in various applications. The indicator utilizes 25 surface mount LEDs consisting of: Green, Yellow, and Red. The 'bullseye' (green LED in center) is calibrated to $\leq \pm 0.5^{\circ}$. Auto detect allows for horizontal or vertical installation. Installation is simple since the indicator utilizes (2) #8 mounting holes. 3-wire hookup leads makes wiring easy.

The Auto Level is typically wired into a switched battery system by connecting the red wire to battery positive and the black wire to battery negative. The third wire (white) is used for calibrating the sensor after vehicle or trailer mounting.





Reverse Polarity Protection: The unit does not operate when input polarity is reversed.

Zero Calibration: The indicator can be zeroed in any mounting orientation.

Factory calibrated for horizontal mounting.

1-Wire Calibration: When the white wire is connected to ground during power-up the

indicator will recalibrate itself. Disconnect the white wire after calibration

for normal operation.




